

By using services offered through our website you automatically accept and assume the obligation to observe the Terms and Conditions set forth below.

These Terms and Conditions (hereinafter referred to THE TERMS) imply an agreement between Bitfinity (THE WEBSITE) and you as an investor or promoter (THE INVESTOR).

The Website properly provides investment and other services through its website <https://bitfinity.io> in accordance with The Terms and other publicly available information on relevant pages of the Website. The Investor trusts his money to the Website in order to get regular financial surplus (RETURN ON INVESTMENT, ROI) from the Website and may decide to benefit from the Website's Affiliate Program.

The Investor must register to get his personal account on the Website. All financial and other transactions are carried out via personal accounts. No financial transactions made outside the Investor's personal account are valid unless otherwise agreed on by the Website and the Investor.

The Investor must be of legal age in his or her country to register a personal account and start investment or promotional activity. The Website may require personal identification of the Investor if it becomes known to or suspected by the Website that the Investor has provided false data during registration.

The Investor understands natural risks of investment activity and agrees to keep the Website free of any harm due to any legal or other procedures in case of situations which are beyond the Website's control.

To invest, the Investor can use one of the four payment methods:

2. AdvCash;
3. Bitcoin;
4. Litecoin.

No other payment methods are accepted.

The Website offers the following investment plans:

Minimal deposit: \$25;
Maximal deposit: \$80,000;
Principal is included in the repayment and is not returned separately;
Repayments are made on all days including weekends and holidays.

2. MOST PROFITABLE:

Principal is included in the repayments and is not returned separately;

To receive a repayment, the Investor should log into his account and request a withdrawal.

The Investor can request a withdrawal in the same payment system and currency which he used for depositing.

The Website checks and executes all withdrawal requests manually, within 24 hours after request.
